V. Work Session

• Dignity For All Students Act (DASA)

Dr. Angela White, Assistant Superintendent for Elementary Education and Administrative Services provided an overview of the legislation designed to protect all students and to afford all students an environment free of discrimination, harassment, or bullying. The *Dignity For All Students Act* (DASA) went into effect for all New York State public schools on July 1, 2012. The PowerPoint presentation is available on the Ossining School District website.

The regulatory amendment to 100.2(1) requires Codes of Conduct to include:

- Provisions prohibiting discrimination and harassment against any student by employees or other students
- Instruction that supports development of a discrimination-free school environment

The Code of Conduct includes protection against a hostile environment, bullying, discrimination, and cyber-bullying. The school climate and culture must promote civility, create a safe and nurturing environment, establish behavioral expectations, effectively address any offending behavior, and provide intervention and support to students.
